On establishing, from 01 September 2017, fees for

library, information and related services provided by SPbU

In order to provide library and information services to individuals specified in clause 2.15 of the Regulations for the Use of Library and Information Resources of St. Petersburg State University approved by Order No. 8009/1 of 26 October 2015 "On regulations for the use of library and information resources" (with further amendments), issued by Senior Vice Rector for Research on the basis of clause 9.1.32 of Order No. 1093/1 of 08 August 2008 "On the distribution of authority between officials of St. Petersburg State University" (with further amendments and additions), issued by Rector of SPbU,

#### I DO HEREBY ORDER:

- To establish, starting from 01 September 2017, fees for providing library and information services at the SPbU Gorky Research Library in accordance with Annex No. 1 to this Order;
- To establish, starting from 01 September 2017, fees for providing related services at the SPbU Gorky Research Library in accordance with Annex No. 2 to this Order;
- To establish that payment for services provided to individuals in accordance with clauses 1 and 2 of this Order shall be made in the form a 100% advance payment made to the cash office of St. Petersburg State University;
- To establish that payment for services provided to legal entities in accordance with clauses 1 and 2 of this Order shall be made in the form a 100% advance payment made by bank transfer;
- Individuals responsible for negotiating contracts on provision of library and information services by SPbU shall
  - 5.1. On a quarterly basis send to the Head of the Department for Accounting and Financial Control (the Chief Accountant) information on the amounts and terms of payment for the provision of library, information and related services;
  - Ensure that the proper complaint management work is carried outwork in accordance with the approved Regulations for dealing with debtors of SPbU;
- Order No. 41/1 of 27 February 2013 "On approval of fees for services" shall be deemed to have lost force as of 01 September 2017; 6.
- 7. Head of the Public Relations Office, T.T. Zainullin, shall arrange for the publication of the copy of this Order in the "Orders related to setting charges for work (services) performed by SPbU on a fee-paying basis" section ("Other Services" subsection) of the SPbU website within one working day from the date of the issuance of this Order;
